Transportation Improvement Program (TIP) Annual Listing of Obligated Projects

The Annual Listing of Obligated Projects (Annual Listing) includes all projects and strategies listed in the Transportation Improvement Program (TIP) for which federal funds were obligated during the immediately preceding program year. The Annual Listing is intended to improve the transparency of transportation spending decisions by providing an accounting for federal funds that have been authorized and committed by the state or designated recipients (e.g. GRTC Transit System) for expenditure on projects programmed in the TIP.

In addition to the introduction the Annual Listing report includes two parts: *"Part One"* is prepared and submitted by VDOT and reviewed by the RRPDC; *"Part Two"* is a listing of projects with "programmed" but no actual obligations. "Part Two" of this report should be considered as a supplement to the VDOT information and it should be noted that the VDOT Annual Listing does not include projects listed in the TIP with programmed obligations and no actual obligations during the reporting period (i.e. FFY 2008). As a result, there are a number of projects with programmed obligations in the Richmond Area MPO TIP for FFY08, which the MPO concludes have had zero actual obligations based on the VDOT reporting process.

The tables on the following pages describe the projects included in the TIP, identify the responsible agency, the amount of federal funds requested/obligated, and the amount of funds remaining to be obligated on the project. A "guide sheet" precedes the Annual Listing for the Richmond MPO. This guide and corresponding footnotes are designed to help the reader interpret "Part One" of the Annual Listing report. Definitions of Interest

- Program Year: the year in which project obligations are reported; for purposes of this report, the program year is the federal fiscal year from October 1, 2007 through September 30, 2008.
- Obligation: An obligation is the federal government's legal commitment to pay the federal share of a project's cost. An obligated project is one that has been authorized by the federal agency and for which funds have been committed. Projects for which funds have been obligated are not necessarily initiated or completed during the program year, and the amount of the obligation will not necessarily equal the total cost of the project. For projects under the auspices of the Federal Transit Administration (FTA), obligation occurs when the FTA grant is awarded. For projects under the auspices of the Federal Highway Administration (FHWA), obligation occurs when a project agreement is executed and the state/grantee requests that the funds be obligated.

Following the VDOT Annual Listing is a section which includes projects that had programmed obligations for FFY 08 in the Richmond Area MPO Transportation Improvement Program (these projects were not listed in the Annual Listing of Obligations provided by VDOT; therefore these projects had zero obligations for FFY08).
